### IMPORTANT NOTES

- All** fines, fees and associated expenses incurred by the Club in respect of any disciplinary process, red or yellow card are the **sole responsibility** of the Player and/or his or her parent(s). Non payment of any such fines will render the player/parent liable to a Club disciplinary hearing and ultimately either suspension or termination of registration.
- Whilst we are not required by law to register with the Data Protection Commissioner, the information that you provide to us will be held and processed in accordance with applicable UK data protection legislation. We will take all reasonable care to keep your personal information secure and prevent any unauthorised access or unlawful use of it. If any of your information changes please advise us immediately so that our records are accurate.
